Comm. Chiumento opened Organizational Meeting for January 3, 2022 at 6:30 p.m.

A motion was made by Comm. Valdez to have Comm. Ralph Chiumento act as temporary Chairman. Seconded by Comm. Dore.

I. <u>NEWLY ELECTED COMMISSIONER TO TAKE OATH OF OFFICE</u>

Review and approve Treasurer's Surety Bond. Determine if it is sufficient, expiration date and renewal. *(The District's current insurance term is March 1, 2021 through March 1, 2022)*

Chairman Chiumento requested to table this until he reviews. District Secretary O'Neill will forward the amount to the Board.

VII. Resolution for Treasurer to pay claims in advance of audit. (#'s 1 – 4 are as per NY Town Law §176-4a).

BE IT RESOLVED, that the Treasurer of the Arlington Fire District is authorized to pay, in advance of an audit by this Board of Fire Commissioners of the Arlington Fire District the following claims. Any such claims must be presented to the next meeting of the Board of Fire Commissioners of the Arlington Fire District for audit:

- 1. Utility payment for light;
- 2. Telephone payment;
- 3. Payment to the U.S. Postmaster for postage expenses;
- 4. Payment for freight or delivery charges.


