- A. Chief William Steenbergh
 - 1. Senator Schumer's office contacted us regarding the second round of a Federal Grant Program for PPE related to COVID that was submitted in November 2020 (the AFG Supplemental). We were awarded \$51,690.48 of which \$46,991.35 is the Federal share and \$4,699.13 is AFD's contribution. It is for personal protective equipment (PPE) only related to COVID, including cleaning, sterilizing and disinfecting supplies.
