- A. Chief Tony Alongi
 - 1. February 24, 2001, Zach's Way will be closed for the American Heart Association Walk form 8:30 a.m. to 11:00
 - 2. Received a thank you letter from Supervisor Barcher thanking FF Fishwick and Lt. Snyder for their assistance during the Red Oaks Mill pond incident.

B. Deputy Chief Jeff Pells

- 2. Mileage Reimbursement the IRS has raised the amount to 34.5 cents from 32.5. Asks the Board to approve this amount.

- 3. Patch for EMT colors are different than current paramedic patch but similar in the style. Will be ordered, expected to be in 6 weeks.
- 4. Mike Fleming has completed class and is now qualified for Assistant Chief. The Board may act on him now.

A motion was made by Comm. Chiumento and seconded by Comm. Philipp to accept Mike Fleming as Assistant Chief, Engine CO. #1.

- 5. Lutheran Care Center letter has been sent by Attorney Comatos. Payment in lieu of taxes is \$37, 344. Attorney Comatos stated that the money is due now.
- 6. Letter from Union to extend the use of 32-74 until July 1, 2001. Chassis are due in the middle of March.
- 7. Cell Phone John Richardson has calls after January 1st. Has a middle of January bill. Comm. Lahey stated that he is responsible for anything after January 1, 2001.

IX. <u>ITEMS / COMMENTS FROM THE FLOOR</u>

A. EMS Director John Kloepfer

- Looking at a program to be approved which allows BLS
 medication to be given to patients by EMT's prior to
 Paramedic arrival to scene. I.E. Epi-Pens, under protocol and
 Albuterol which requires medical control contact.
 - a. Not everybody has to buy into it. This is an option, but only qualified EMT's will be allowed to participate.
 - b. EMT would have to have or already have taken a medication module in new EMT curriculum or take a medication module here, approx. 2 hours to show how to use Epi-Pen, put together Albuterol, use of the drugs, etc. This would be a one time course.
 - This program will be an additional hour of training tacked on to the Defib review. It will be done biannually.
 - d. Cost/Impact is minimal. Epi-Pens cost \$41.19 each and Albuterol is 42 cents each.
 - Medical Director is against this program, suggesting it will lose more volunteers.
 Fairview FD uses this program.
- Looking at Public Access to Defibrillation for our department.
 Not everyone has to buy into. Allows firemen to be authorized to use the defibrillators on the first attack engines.
 Requirement: a 2- 3 hour course plus CPR, once a year.

A motion was made by Comm. Chiumento and seconded by Comm. Philipp to authorize the Albuterol program, the Epi-Pen program and Public Access to Defibrillators program.

- B. Treasurer Jim Passikoff
 - 1. Submitted Preliminary December 2000 Financial Report.
- C. Attorney Gerard Comatos
 - 1. Has not heard any response from Engine Co. #1 regarding the Shat Trust agreement. Suggests that we hold a meeting next week with the Engine Company. Comm. Lahey stated that it does not have to be a Commissioners meeting.
- D. Assistant EMS Director Dave Violante

1. PENS Program: a walk through is scheduled on March 1- 2 by their company. A week or two after that, they will start education.

- E. Ray Tetrault took OSHA II class. Informed by instructor that he couldn't put his SCBA on in one minute, so he failed and is now classified as exterior FF only. He lost his Interior status. His time was 1:10. He feels that safety comes first and that the time limit should be looked into again.
 - a. Comm. Philipp stated that he believes the one minute mark is only a guide to show how familiar a person is with the equipment. It needs to be looked into by the Chiefs Council.
 - b. DC Pells stated that the "norm" is 45 seconds. They felt that it is a fair standard.

Lengthy discussion on "proper" standards and the impact this will have on the volunteers.

- c. Chief Alongi stated that they will look into it.
- F. Chip Grundon Local 2393 President
 - 1. One Item for Executive Session.

A motion was made by Comm. Philipp and seconded by Comm. Chiumento that we adjourn to Executive Session at 8:45 p.m.
