#### PURCHASE OF ROCHDALE FIRE CO. FIREHOUSE SEQRA - UNLISTED ACTION

**WHEREAS**, the Board of Fire Commissioners of the Arlington Fire District ("Board" or "District") proposes to acquire that certain parcel of real property, which is improved by the Rochdale Fire Company firehouse (Station 4) located at 1075 Dutchess Turnpike, Poughkeepsie, New York 12603) ("Proposed Action");

**WHEREAS**, the Proposed Action is subject to review under the State Environmental Quality Review Act and the Regulations promulgated thereunder ("SEQRA 6 NYCRR Part 617"); and

**WHEREAS**, the Board has considered the information and documentation describing the Proposed Action and its impacts on the environment in Part 1 of the Short Environmental Assessment Form, annexed hereto as Exhibit "A," and made a part hereof.

**NOW THEREFORE**, **BE IT RESOLVED**, that the Board of Fire Commissioners of the Arlington Fire District hereby:

1. Classifies the Proposed Action as an Unlisted Action under SEQRA 6 NYCRR Part 617;

- 2. Directs KARC Planning Consultants, Inc., the District's planning consultant, to circulate Part 1 of the Short Environmental Assessment Form to other potential involved and/or interested agencies identified in Exhibit "A" annexed hereto; and
- 3. Under the applicable standards of SEQRA 6 NYCRR Part 617.6, upon confirmation from the involved agencies that there is no objection to the Board being declared lead agent or the lapse of the thirty (30) day time frame from the date Part 1 is circulated to the other potential involved and/or interested agencies, whichever occurs first, the Board shall be declared the lead agency for the SEQRA review of the Proposed Action.
