- A. Chief William Steenbergh
 - 1. New employees start this Wednesday; training all set. Academy starts later in the month.
 - 2. Seagrave prebuild conference requesting to send the Apparatus Committee (8 members) to Wisconsin to review the two set of specs March 27th 29th. Cost approximately \$6K \$7K.

Discussion.

A motion was made by Comm. Longi to approve the Apparatus Committee to be sent to Wisconsin to review specs March $27^{th} - 29^{th}$ of this year. Seconded by Comm. Dore.

 - 3. Swift Water training requesting to send ten (10) members (names TBD) to Oriskany, NY for training in May. Would be a Dutchess County only training class consisting of AFD, LaGrange FD, Poughkeepsie FD and the DC Sheriff's Office. Class is paid for by the State. Only AFD cost is backfill. The State will come during the summer to teach a Boat class (which is required) on the Hudson River. This will increase the number of certified members on each group, which would decrease OT on call backs.

A motion was made by Comm. Longi to approve the Swift Water training in Oriskany. Seconded by Comm. Dore.

6. Rose & Kiernan, (now NFP) notified him Thursday regarding our insurance renewal. It automatically renews March 1st and there will be a 35% increase with our current carrier, ESIP, from \$76K to \$103K for the year. NFP recommends going with VFIS – 23% increase with the same coverage for \$94K. VFIS is also brokered by Marshall & Sterling (our local broker) and he recommends switching brokers and going with VFIS. There will be no lapse in coverage if notified by noon tomorrow.

Discussion.

A motion was made by Comm. Chiumento to switch our insurance carrier with Marshall & Sterling for the VFIS policy contingent upon no lapse in coverage. Seconded by Comm. Van Itallie.
