Contacted other departments regarding their policy on cleaning of uniforms. LaGrange, Fairview, Roosevelt, New Hackensack and Gardiner do not pay for uniform cleaning. New Hamburg does. Need to honor Board decision regarding the removal of one of the patches. Possibly keep open until June to see where we are at. Resolution said "jackets", not "uniforms".

Comm. Dore agrees to not do 30 jackets in closet, which he said at last meeting. Comm. Beretta stated to get the jackets done for the members who do attend parades. The Board agrees, for this one time, to include the career staff.

STANDARDIZATION RESOLUTION

WHEREAS, the Board of Fire Commissioners of the Arlington Fire District has authorized the replacement of its Self Contained Breathing Apparatus (SCBA) and has authorized the Chief of the District to advertise for bids in accordance with the requirements of the General Municipal Law, and

WHEREAS, the Board of Fire Commissioners is aware of the fact that the majority of Fire Districts/Departments in the area served by the Arlington Fire District, including the City of Poughkeepsie, Roosevelt, LaGrange, Pleasant Valley, Hyde Park, and New Hamburg Fire Districts amongst other emergency service providers all utilize the AScott Pack@ brand of the SCBA, and

WHEREAS, due to the fact that the majority of local fire service providers have been trained on the AScott Pack@ system and for the convenience and availability of exchange parts in the event of an emergency or damage to the SCBA of any one responder the availability of identical equipment from another department will greatly aid in the emergency service provider=s ability to respond, therefore be it

RESOLVED that the Arlington Fire District pursuant to the authority granted under General Municipal Law '103 (5) for reasons of economy and efficiency determine that there is a need to standardize the SCBA systems under the AScott Pack@ brand and therefore authorize bidding for the SCBA systems for AScott Pack@ equipment.
