The Board previously had a discussion regarding having first two engines respond code 3, manpower, etc. Comm. Richardson has a problem with first in, first out. Comm. Chiumento doesn't agree with drivers coming to a complete stop. Discussion on drivers coming to complete stops with Code 3. Wants all drivers to follow the New York State Vehicle and Traffic Laws as related to emergency driving.
