X. DISTRICT STAFF ITEMS

- A. Chief William Steenbergh
 - 1. Stipulation of Agreement proposal between the District and the Local.

Chairman Chiumento would like to discuss in Executive Session.

2. Recommends the Board to consider holding a special meeting for the purpose going into Executive Session with the Local to discuss negotiations and employment history of particular individuals. Due to NYS Governors Executive Order 202.1 and COVID, no public will be allowed in attendance, but recommends having an in person Executive Session, while still adhering to the 10 or less people and maintaining social distancing. Will still have the Zoom meeting for the public portions and then adjourn to Executive Session.

The Board agreed to conduct a special meeting on Monday, June 8, 2020 at 5:00 p.m.

3. Town Supervisor would like a point of contact for the Consolidation Study and if we developed a list of questions based off the presentation we went to.

Brief discussion: The BOFC agreed to have Chief Steenbergh and Commissioner Longi be the points of contacts for the Town. The BOFC agree that this is not financially feasible at this time, but are willing to listen to meetings.

- 4. Update: Raymond Avenue School Project the Town Board adopted a Resolution approving the PILOT but the Fire District is not part of it, fully taxable. Reached out to our Attorney in advance to confirm this. This is also on the June 4th Dutchess County IDA agenda. Our Attorney will confirm with them that the Fire District is exempt from the PILOT.
- 5. The Fire District applied for the "FEMA Assistance to Firefighters Grant Supplemental" which is specific to COVID 19 reimbursement for personal protective equipment (PPE) and cleaning products only. It's divided into three categories reimbursements up to date, immediate expenses and future needs for calendar year 2020 2021. The total budget is \$172,363.78. If approved, the Fire District would have to pay 10% which is \$15,669.00. Should know in 4 6 weeks.
- 6. Still have ability to do the "FEMA Disaster Grant" to get reimbursed for the COVID expenses, but can't double dip. Waiting to see what we get from the other one first. This one would allow us to recover overtime costs, PPE and cleaning supplies.
- 7. COVID Operations update started loosening up the restrictions. North and South Battalions can move around; hose testing have started. Practicing social distancing.
- 8. Personnel Administrator update received 10 resumes. Reviewed resumes and 6 did not meet the posted requirements set forth in the job description. Next step will be to conduct phone interviews.
- 9. Received an email that was forwarded this afternoon from the Chairman regarding the graduation at Arlington High School and their request for the local fire departments to send a fire engine in support of their graduates. Contacted the LaGrange Fire Chief; they are holding this June 15th & 16th in two sessions on each day: 8am-12pm and 1pm-5pm; we could send a reserve rig and is confident the Union would participate.
- 10. Capital projects for firefighter safety and equipment for Board consideration; all need replacement and all good for at least 10 year life expectancy.

- A. Bail out systems; approximately \$87K \$88K based on committee research and demonstrations. Bid process will need to occur.
- B. Washing Machine at HQ; recommending a heavy duty one for HQ and move this one to ROM. Approximately \$10K 12K range.
- C. Nomex Hoods; need something different; three firefighters became sic with neck and throat cancers. Current ones are not proper level of protection; looking at issuing one and do an exchange after every call, would be laundered so everyone has a clean hood. Approximately \$10K.
- D. Turnout Gear; 3 5 sets; to keep in line with the plan past Chief Gallante developed of replacing gear so its not a big financial impact.

Total of \$125K range to come out of a permissive referendum or from the Fund Balance. Will discuss further at a future time.

- B. Assistant Chief Eric Philipp
 - 1. School requests on the agenda tonight for three volunteers; hopes the Board supports it.
- C. Director of EMS David Violante
 - 1. Thanked those during National EMS Week; extended appreciation to Vassar Brothers Medical Center, Mid Hudson Regional Hospital and Rudy's Bagels for providing refreshments.
 - 2. Started COVID antibody testing at HQ in conjunction with Pulse MD Urgent Care, through a blood draw. No results will be given to HQ; its for a piece of mind for those that want to know. Working on career staff and will open it up to the volunteers and Commissioners when they get through the career staff.
 - 3. State items coming up Lab license renewal came through; "Certificate of Need" recertification's for our Ambulance Agency and/or ALS First Response Agency due at end of the year.
 - 4. Zoll maintenance contract bill is now an annual bill. They do maintenance to our defibrillators, provides discounts. Helps with budgeting purposes.
 - 5. COVID calls have decreased; acuity has increased.
 - 6. CME's have been put online; certifications have been extended out by 90-120 days; everyone in good shape.

- D. Treasurer James Passikoff
 - 1. No financial report.
 - 2. Anticipates having the AUD done by end of this week; will provide copy to the Board. Hasn't heard back from Albany on the extension, but doesn't see a problem with it.
