The meeting was turned over to Captain Tarquinio who presented a proposal on behalf of the apparatus committee to purchase a 1998 Spartan 3D Rescue truck from Washingtonville Fire District in the amount of \$50K. Requesting additional funds to redo the graphics, seat brackets and any additional items that may be needed.

A motion was made by Comm. Valdez to purchase the piece of apparatus, for up to \$65K to be taken out of the fund balance, from Washingtonville Fire District. Seconded by Comm. Dore.
