Dear Chief Steenbergh and Commissioners,

According to the definitive history of the Red Oaks Mill Fire Company, written by the late Ray Radzivila in 1992, the initial planning to form a fire company with the goal to "improving fire protection and providing social activity facilities" began in the mid-1940s. "Committees were formed, officers elected, and a constitution drafted. Finally, the list of officers and members was submitted to the Arlington Board of Fire Commissioners and was approved and accepted by them on July 8, 1946; from this date forward, we were in business."

On July 8, 2021, the members of the Red Oaks Mill Fire Company will be celebrating our 75th Anniversary. Throughout these years, the volunteers of this company answered countless emergency calls and hosted various community events for the residents of Red Oaks Mill and the southern portion of the Arlington Fire District.

To commemorate this anniversary, the executive board and current members of the Red Oaks Mill Fire Company request that this letter be read during the first Board of Fire Commissioners meeting in July 2021 and entered into the minutes of that meeting.
