- A. Chief William Steenbergh
 - 1. RE: COVID, travel restrictions and training being canceled: applied to FEMA for time extensions on all the open Grants. We were granted a six (6) month extension for the Fire Investigation Grant; expecting an additional six (6) month extension because training hasn't been scheduled yet; anticipates an extension for the Officers Training Grant due to being unable to go or get instructors.
 - 2. Spoke with Ed Holohan from PenFlex; Ed provided a draft resolution from another fire district for the Board to review regarding LOSAP & COVID; he and Ed discussed cost estimates and requests that the Board invite him to attend a future meeting to discuss LOSAP and the actuarial portion. Suggested the 1st meeting in September. The Board agreed. Will reach out to Ed to confirm a date.
 - 3. Received a request to replace the treadmill at HQ. Funds to come from the joint physical fitness fund; cost is \$3250.

A motion was made by Comm. Adams to authorize the purchase of a treadmill not to exceed \$3300, the funds to be taken from the physical fitness fund. Seconded by Comm. Chiumento.
