    - 2. Requesting Board acceptance of the Assistance to Firefighters Grant (AFG) which we were awarded \$770,000 for Paramedic Training. The Fire District's responsibility is \$70,000. This grant will cover the cost to take ten (10) firefighters off the line and send them to obtain paramedic certification training.

- 2. Still having issues with submitting the Annual Update Document (AUD) to NYS. Has tried contacting NYS regarding obtaining the pension liability numbers and they are not returning calls or emails.

Chairman Chiumento wants it submitted without the numbers he is waiting for. At least it's submitted and can revise it. Treasurer Passikoff stated he will submit by September 1<sup>st</sup> if he doesn't get the numbers by then.
