RESOLVED that all career and volunteer firefighters and officers, with the exceptions of the Chief, Deputy Chief, and the Director of Emergency Medical Services, shall act under the orders and control of the Assistant Director of Emergency Services in all areas of emergency medical service.

It has been the policy of the Board that we don't want those bills going to individual taxpayers, we would accept that as a cost for this setup.
