Chairman Chiumento reported that the current preliminary budget is in the amount of \$20,362,000 which \$19,418,000 is to be raised by real estate taxes; under the tax cap; .238 cents per thousand decrease in the tax levy. The retirement numbers have not come in yet and it could change things. He gave a brief overview of the numbers.

A motion was made by Comm. Griffing to adopt the 2022 budget. Seconded by Comm. Longi.

Comm. Chiumento wanted to confirm the preliminary budget includes the fund balance. As per Treasurer Passikoff, yes.

- A. Chief William Steenbergh
  - 2021 Fire Prevention School Program In 2019, Battalion Chief George Finn did 10 elementary schools and 4 nursery schools utilizing the fire safety trailer, fire apparatus and presentations. Over 3,000 students were educated with the assistance of on duty staff and 96 hours of overtime. In 2020, there was no fire prevention in the schools due to COVID. The schools are requesting the fire prevention program for 2021. He is respecting their restrictions and we made the decision not to utilize the fire safety trailer due to close proximity of the children and timing to disinfect. He is requesting 62 hours overtime. Chief recommends approval to educate the children and be out in the community.

A motion was made by Comm. Chiumento to authorize that. Seconded by Comm. Longi.
