TAX ANTICIPATION NOTE RESOLUTION DATED OCTOBER 8, 2007

A RESOLUTION AUTHORIZING THE ISSUANCE OF \$2,750,000.00 TAX ANTICIPATION NOTES OF THE ARLINGTON FIRE DISTRICT, DUTCHESS COUNTY, NEW YORK.

BE IT RESOLVED, by the Board of Fire Commissioners of the Arlington Fire District, Dutchess County, New York, as follows:

Section 1: The issuance of tax anticipation notes of the Arlington Fire District in an amount not to exceed \$2,750,000.00 is hereby authorized.

Section 2: The notes herein authorized are issued in anticipation of the collection of real estate taxes and/or assessments levied on all the taxable real property in said Fire District without limitation as to rate or amount sufficient to pay the principal of and interest on such notes as the same become due and payable.

Section 3: The fiscal year for which such real estate taxes and/or assessments were levied or are to be levied is the fiscal year commencing January 1, 2008.

Section 4: The notes shall mature on the next April 15<sup>th</sup> following the date of their issuance and the maturity of said notes shall not extend beyond the close of the applicable period provided in section 24:00 of the Local Finance Law.

Section 5: The faith and credit of said Arlington Fire District, Dutchess County, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such notes as the same respectively become due and payable.

Section 6: Subject to the provisions of the Local Finance Law, the Approved - Board of Fire Commissioners Monthly Meeting Minutes - October 8, 2007

power to authorize the issuance of and to sell tax anticipation notes herein authorized is hereby delegated to the Fire District Treasurer, the chief fiscal officer of the Fire District. Such notes shall be of such manner, as may be prescribed by said Fire District Treasurer, consistent with the provisions of the Local Finance Law.

Section 7: All other matters except as provided herein relating to the notes herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein, and the manner of execution of the same, shall be determined by the Fire District Treasurer, the chief fiscal officer of the Fire District. Such notes shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, as the Fire District Treasurer shall determine consistent with the provisions of the Local Finance Law.

Section 8: The validity of such notes may be contested only if:

- (1) Such obligations are authorized for an object or purpose for which said Fire District is not authorized to expend money, or
- (2) The provisions of law which should be complied with at the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty (20) days after the date of publication, or
- (3) Such obligations are authorized in violation of the provisions of the Constitution.

A motion was made by Comm. Duderstadt and seconded by Comm. Muckenhaupt to approve the Tax Anticipation Note Resolution dated October 8, 2007 authorizing the issuance of \$2,750,000.00 and including what is articulated in sections 1 through 8.
