BE IT RESOLVED, by the Board of Fire Commissioners of the Arlington Fire District ("Fire District") hereby determine that the Annual Election of the Fire District shall be held on

December 8, 2020 between the hours of 5:00 p.m. and 9:00 p.m., with polling places at the Red Oaks Mill Fire House, 213 Vassar Road for Wards 1, 2, and 5, and at District Headquarters, 11 Burnett Boulevard for Wards 3, 4, and 6 for the purpose of electing one (1) Fire District Commissioner for a five (5) year term of office commencing January 1, 2021 and continuing through December 31, 2025;
