  - 1. Discussed the "I Am Responding" program. Not being used for scheduling as wanted, using more for responding. Wants more people to sign up. Will be receiving upgrades soon. Was able to extend contract until 12/31/2008.
  - 2. Changing of Patches the cost of getting a 2 x 3 flag patch, removal of old patch, sew on new one will cost \$2.50 per patch. Issue being that uniforms that have been dry cleaned, the glue from the old patch has adhered to the uniform. Wants to try it out on a few to see before the Board makes a decision. We currently have 150 200 uniforms.

  - 1. Submitted the October 31, 2007 report for the District suggests we make the pension payment by December 15<sup>th</sup> to avoid \$12,500 in interest if we wait until February 1st to pay it.

  - 1. Asked the Board how many of them use the "Fire District Officers Guide", due to updated supplements being issued, at \$90 per supplement.
  - 2. VFIS came to AFD to conduct a survey and made some recommendations:
    - A. Physicals initial base line physical and date of completion. Suggests, by age, periodic physicals.

- The Board stated that we already do initial physicals, but will be implementing periodic physicals next year.

  Haven't had any issues with the hose coming off the trucks in the past, but will look into it.

- A. Assistant EMS Director David Violante
  - 1. Junior Resuscitation Mannequin that was purchased, the use is going very well. Assisting with skills. We are sharing EMS training with Fairview, LaGrange, City of Poughkeepsie.
  - 2. One (1) Contractual Item for Executive Session
- B. Woman in the audience (did not identify herself)
  - 1. Asked if the budget that is noted on our website has been passed yet and

wanted to know where the "income" line comes from and if it comes from donations.

- The Board stated yes, the budget has been approved. Treasurer Passikoff stated that the "income" comes from Interest Income and Payment in Lieu of Taxes.

2. Wanted to know who the candidates were for this years Commissioners election and what station is the vacancy from?

-The Board stated that there is no station and that the vacancy is to fill the term of the Commissioner who resigned. Secretary O'Neill told her we have three candidates for the five year term and one for the one year term; each name along with a blank spot for a write in is on the ballot. Secretary O'Neill gave her the names of the candidates when the meeting was over.
