X. DISTRICT STAFF ITEMS

- A. Chief William Steenbergh
 - 1. Governor Hochul recently signed an amendment to Chapter 481 of the Open Meetings Law, which requires that records to be discussed at the meeting be posted or made available within 24 hours of a meeting.

Brief discussion. Postings will be done by end of business day on Thursday's prior to the meeting with the exception of the January 3rd meetings. Those agendas (organizational & regular) will be posted December 23rd and the Abstract will be posted January 3rd, due to the Chief and District Secretary being out of the office.

2. Leary's Firefighters Foundation – Captain Rinck applied for a grant and we were awarded \$13,450 to replace our FAST equipment.

 - 4. Two are expected to retire in December with a possibility of a third. Recommendation from Treasurer Passikoff that their

accumulated sick time cash outs be taken out of the Employee Benefit Accrued Liability Reserve Fund not to exceed \$300,000.

A motion was made by Comm. Longi to approve the transfer of funds to pay for the costs out of the Employee Benefit Accrued Liability Reserve Fund for the cash in of their accumulated time, not to exceed \$300,000. Seconded by Comm. Griffing.

 - 5. Volunteer Firefighter Cancer Insurance Policy two options for 2022. The basic plan, which is required by NYS law, covers a limited number of cancer diagnoses for a total of \$3,622.45. The enhanced plan covers any and all diagnoses for \$4,646.
