Both were originally approved on October 19, 2020 as alternates contained in the "Resolution – Arlington Fire District Board of Fire Commissioners Annual Fire District Election".

X. DISTRICT STAFF ITEMS

- A. Chief William Steenbergh
 - 1. Update on Volunteer Firefighter Cancer Law discussed the updated and modified law which allows substitute documentation to meet requirements; net result is 23 already covered, mandatory to add 6 additional volunteers and will be an additional \$700 per year. Also a local option for Board consideration coverage to include exterior firefighters for a total of 19 volunteers.

Approximately \$2,250 for the first year and it will decline every year after that for up to five years after they leave service. Total for the both is approximately \$5,700 for the year.

Brief discussion.

A motion was made by Comm. Chiumento to approve the exteriors with Volunteer Cancer coverage. Seconded by Comm. Valdez.

They are assigned to the Training Bureau to do in house training. Lt. Chuck Fager started effective today and will be with the Training Bureau. He goes to FLSTP in January.
 - 3. Commissioner Election & COVID we have purchased plexiglass shields for the Inspectors; changing the design of the rooms for social distancing; meeting with the Inspectors ahead of time to review disinfecting procedures; individual pens; voting booths modified to be wiped down; will provide masks, sanitizer.

Chairman Chiumento reported that we received Civil Service approval today for the new Battalion Chief positions.

Chiumento to, at a date to be determined by the Chief, promote to provisional Battalion Chief – Andy Mihans, Paul Galletta, Gus Antalek, George Finn, Chris Mill and Adam Kangas; to probationary Captain – Gary Lewis, Chris Saya, Joe Tarquinio and John Dunderdale; and to provisional Captain – Lou Cassinelli, Richard Muellerleile, Bill Tompkins, Justin Drum and Chris Rinck. Seconded by Comm. Griffing.
