  - A. Comm. Valdez reported that today is National U.S Coast Guard Day and recognized all those in the U.S. Coast Guard for all the services they provide.

## 10. **DISTRICT STAFF ITEMS**

- A. Chief Adam Kangas
  - 1. Uniform Bid results we rejected the first set of uniform bids that came in because it was difficult to decipher who won or who obtained the lowest price because of the amount of different items for our uniforms. Our Attorney worked with us to redo the bid process. We sent out another bid for uniforms and Battalion Chief Dunderdale, who heads the uniforms and gear, made a determination and recommends the following be awarded:
    - A. MES uniform pants, uniform shorts, uniform shirts, job shirts, belts, winter hats, BDU shirts and BDU pants
    - B. New England Uniforms jackets and coveralls

Chief Kangas is requesting the Board to accept the recommendation and award those specific items to those two companies.

Comm. Van Itallie made a motion to accept the two separate bids for the two separate sets of items. Seconded by Comm. Valdez.

  - 2. Headquarters is currently being painted on the outside. Thanked the staff for assisting in preparing the building and removing the plant life. Also thanked the staff for painting the bays at Station 3.
  - 3. The acquisition of Rochdale was approved by the NYS Attorney General. Rochdale to donate at no cost, with the exception of legal fees and incidentals. August 14<sup>th</sup> is the scheduled closing date. Chairman Dore and himself will be attending the closing.

Comm. Chiumento read the following Resolution:

#### RESOLUTION

APPROVING CONTRACT OF SALE AMENDMENT AND CLOSING ON ACQUISITION OF ROCHDALE FIRE COMPANY PROPERTY

WHEREAS, the Board of Fire Commissioners of the Arlington Fire District ("Board") had previously authorized entering into a contract of sale with the Rochdale Fire Company to acquire the Rochdale Fire Company firehouse (Station 4) located at 1075 Dutchess Turnpike, Poughkeepsie, New York 12603 ("Property") for the sum of \$300,000, which sum was to be

fully funded from the District's capital improvement reserve fund for the purpose of acquiring the Property; and

WHEREAS, the Board and the Rochdale Fire Company subsequently agreed to amend said contract of sale to acquire the Property for no consideration; and

WHEREAS, the New York State Attorney General has approved a petition permitting the Rochdale Fire Company to sell the Property to the Board to be used for public purposes of the Arlington Fire District for no consideration;

NOW THEREFORE, BE IT RESOLVED, that the Board of Fire Commissioners of the Arlington Fire District hereby approves the amendment to the Contract of Sale to acquire the Property from the Rochdale Fire Company for no consideration; and further authorizes the Chairman to execute said amendment to the Contract of Sale and all other documents required to secure the closing on the acquisition of such Property.

Comm. Van Itallie made a motion to approve that Resolution. Seconded by Comm. Valdez.

Comm. Van Itallie asked when we will stop paying rent. Vice Chairman Chiumento stated that the last month will be prorated.

  - 4. Two (2) new firefighters will be attending Utica Fire Academy starting on the 18<sup>th</sup> and should be back in house around Thanksgiving time frame.
  - 5. Currently canvassing off the new Firefighters list to start preparations for after the New Year with manpower and hiring. They need to be at minimum an EMT to be considered or hired. District Secretary O'Neill and Personnel Administrator Hastie are vetting the candidates. It's a process and doesn't want to rush with the background checks, etc.
  - Fire Equipment Mechanic is being worked on and developing candidates for that position based on the Resolution from the last meeting.
