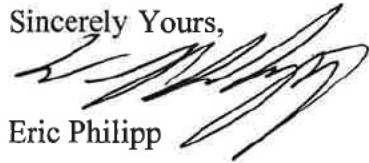

In Chapter 177 of the Laws 2025 the Legislature and the Governor have amended the General Municipal Law, the Executive Law and the State Technology Law in relation to municipal cybersecurity incident reporting and exempting such reports from Freedom of Information Law requirements. They also set new standards for cybersecurity awareness training for government employees, data protection standards, and cybersecurity protection. The sponsors of these new laws noted that their purpose is to have the Division of Homeland Security and Emergency Services ["DHSES"] *"provide information, guidance and training on cybersecurity issues to local governments and public authorities, establish certain reporting requirements for cybersecurity incidents and ransomware attacks, and establish a framework for state agencies to respond to cybersecurity incidents."*

LEGISLATIVE UPDATE: EXTENSION OF TIME TO ADOPT CURRENT REAL PROPERTY TAX LAW EXEMPTION PROVISION FOR VOLUNTEER FIREFIGHTERS

In 2022 the Legislature and the Governor enacted Chapter 670 of the Laws of 2022 to permit volunteer firefighters in all counties in the state to possibly receive a partial real property tax exemption on residential real property they owned and resided in. It created a new Real Property Tax Law §466-a. The objective of that law was to create the local option in all counties to provide volunteer firefighters [and volunteer ambulance workers] with a partial real property tax exemption on residential real property they owned and resided in since prior to that enactment the exemption was only available in a limited number of counties. That law created the opportunity for more counties and local governments to authorize the partial real property tax exemption and called for those counties and local governments already providing the partial real property tax exemption to convert to the system offered by the new Real Property Tax Law §466-a.

In recent years, your association has published articles in *Fire District Affairs* detailing the process for exceeding the real property tax levy cap, a crucial step in the budget approval process. Given the rising operational costs, it is highly probable that your Board will need to consider overriding the tax levy cap of 2.0% for the 2026 budget. Additionally, numerous federal and state unfunded mandates must be accounted for when drafting your budget. The district's proposed budget will be the central topic of discussion at the Annual Budget Hearing, which your Board is required to schedule for a date in the third week of October.

Such a letter shall be submitted to the Secretary of the Association of Fire Districts of the State of New York, Inc. The new Secretary of the Association is Donna Marano.
